The above entitled cause came on regularly for trial on February 5, 1969, in Department 11 of the above entitled Court, LESTER E. OLSON, Judge presiding, Jack Dunaway appearing as counsel for plaintiff, and Zagon, Schiff, Hirsch, and Levine, by Daniel S. Mark, appearing for defendant, and the Court having heard the testimony and considered the evidence, and having signed and filed herein its findings of fact and conclusions of law, now makes the following judgment:

IT IS ADJUDGED that defendant is the father, and that Adina Etkes is the mother of Hugh Donald Krampe, a son, born May 2, 1952.

DEFENDANT IS ORDERED to pay to Adina Etkes, guardian ad litem for plaintiff, the sum of \$2,500.00 as and for accrued child support for the period commencing May 31, 1968, and ending February 28, 1969. Said sum shall be for the use and benefit of plaintiff, and shall be placed in a blocked account withdrawable by plaintiff on his 21st birthday, that is, on May 2, 1973, or upon further order of the Court.

1 DEFENDANT IS FURTHER ORDERED to pay to Adina Etkes, guardian ad
2 litem, for the use and benefit of plaintiff, and as and for the support and main-
3 tenance of plaintiff the sum of \$250.00 monthly, commencing March 1, 1969,
4 and continuing on the first of each and every month thereafter until plaintiff reaches
5 his majority, or until further order of Court.

6 DEFENDANT IS ORDERED to pay to Jack Dunaway, attorney for plaintiff,
7 and as for counsel fees and costs for plaintiff, the sum of \$2,100.00, payable
8 on or before March 15, 1969. Said attorney shall repay any sums received by
9 him in connection with this action to the parties advancing the same.
